Grosser Zunftsaal

In the spacious dining hall on the first floor, fondly called a lounge by members of the guild, a large front window bids views of the Rathaus directly opposite and the Limmatquai promenade. And inside, the regency style walnut clad ceiling lends the dining space a noble atmosphere.

Kleiner Zunftsaal

With its original wood-paneled walls, a historic tiled stove and stucco ceiling, the room on the second floor offers the perfect space for both private and business meetings, celebrations and more.

Saal zur Weissen Rose

The hall on the second floor is shaped by imposing walnut cabinets, in which the treasures of the guild are stored. And yet another eye-catcher is the historic tiled stove.

Ratstube

The Ratstube served as a council chamber for the secret talks of guild members in times gone by - whereas today it's available for business meals, presentations and meetings in exclusive surroundings.





General Terms and Conditions of Saffran AG

General services provided by Saffran AG

Saffran AG rents premises owned by the Saffran Guild, Limmatquai 54, 8001 Zurich, and provides a comprehensive catering service in accordance with each specific contract. At the client's request, within the scope of its organisation of events it also carries out the necessary co-ordination with suppliers and takes care of the overall event management.

Reservations

All details required for the organisation of an event, including compilation of menus and selection of wines, seating arrangements, table settings and room decoration, printing of menus, provision of auxiliary equipment, etc., must be submitted in writing to Saffran AG not later than 14 days prior to the event. These details shall only become binding after they have been confirmed in writing by Saffran AG and re-confirmed in writing by the organiser. The latter shall submit a precise programme to Saffran AG by not later than 5 days prior to the event.

Number of participants

The organiser of the event undertakes to notify Saffran AG of the definitive number of participants as early as possible, though in any case by not later than 3 days prior to the event. Notifications of a change in the number of participants up to a maximum of 10% are accepted up to three business days prior to the event. Such notifications are binding. If Saffran AG should not receive a notification of the definitive number of participants by the stated deadline, it shall assume that the number of participants cited in the confirmation of the contract is binding, and shall subsequently invoice the organiser accordingly (subject to any effective increase in the number of participants).

Validity of rental agreement

Until such time as a rental agreement has been signed by the client and returned to Saffran AG, or until such time as Saffran AG has confirmed the rental agreement, Saffran AG reserves the right to rent the premises to another party. With respect to any associated liability, all risks shall be borne by the client unless Saffran AG should be required to bear such risks in accordance with compelling legal provisions.

Specific services provided by Saffran AG

The services to be provided by Saffran AG are based on its written confirmation of contract. Any services provided beyond the scope specified in the agreement shall be duly invoiced in addition. In the event of short-term changes on the market, non-availability of goods or significantly increased prices, Saffran AG reserves the right to modify its services and offer the client an equivalent alternative. Saffran AG is entitled to entrust the performance of its contractual services to a third party. The services of Saffran AG may also include mediation of technology, artists and musicians, decorations, etc. The client shall, however, conclude the associated agreements directly with the respective providers. Saffran AG charges a handling fee of 15 percent for all third-party services.

Media, advertising, external communication, sponsoring

All printed matter, notices published via the Internet, and information publicised via radio and television, in which the name Saffran AG (and/or Saffran Guild) and the Saffran logo are used publicly, must be submitted in advance to Saffran AG for its approval. Sponsoring activities must be discussed and approved by both parties.

Cancellation

In the event that a definitively booked event should be cancelled, the following costs shall be invoiced:

- a) Up to 30 days before the event: Basic rent will not be charged, as long as the premises can be rented to another party.
- b) Between 30 and 20 days before the event: Basic rent, plus 30% of offered turnover.
- c) Between 10 and 0 days before the event: Basic rent, plus 60% of offered turnover.

As a rule, an initial general offer is made free of charge. Should the client request a second, detailed offer but no agreement should subsequently be signed, Saffran AG shall be entitled to invoice the client for compensation of its costs (expenses and sundry costs) associated with the activities and services it has carried out in connection with the second offer.

Withdrawal from contract by Saffran AG

In the event that the client should infringe against the provisions of the contract or Saffran AG should have grounds for assuming that the event could have a negative effect on the course of business, represent a safety risk or damage the reputation of the company, Saffran AG may cancel the event any time and terminate the contract, subject to its own remuneration entitlements (cf. Cancellation), without thereby incurring any negative legal consequences for itself. This clause shall also apply in the event of force majeure, though without a remuneration entitlement.

Extensions, permits

Events requiring permits for extensions give rise to additional costs for Saffran AG, which the client is required to cover in accordance with the relevant banquet documentation of Saffran AG.

Delays and deferral

The Saffran AG works according to the timeframe agreed upon with the customer. In case of delays or last minute changes before or during the event without a minimum of 48 hours notice in writing, we reserve the right to charge the client for the labor cost incurred as well as event related charges by third parties.

Terms of payment

Invoices are payable within 15 days from date of issue. After the contract has been definitively confirmed, Saffran AG may request a down payment equivalent to 30 percent of the total contractual amount. The basis for the use of premises of Saffran AG is a catering turnover guarantee. In the event that the agreed minimum turnover should not be reached, Saffran AG shall also invoice the client for the difference.

General liability

Saffran AG may only be held liable for grossly negligent or intentional damage of a contractual or non-contractual nature, and only for direct damages. It cannot be held liable for any other damages, in particular resulting from minor negligence, or for any indirect damages such as loss of earnings. The client shall be liable for all damages or losses caused negligently or intentionally by his or her employees, representatives, guests and any other persons who may be on, or in the vicinity of, the premises of the Saffran Guild in connection with the event. The client shall fully release Saffran AG from all claims under civil and public law that may be asserted by public authorities or third parties (including participants at the event, guests or employees, and contractual partners) against Saffran AG in association with the event, and shall bear all costs, including any legal fees and court costs, as well as any compensation payments or fines.

Recognition of agreements covered by these Terms and Conditions

By signing the definitive booking or order confirmation, the client expressly confirms that he or she has received these Terms and Conditions of Saffran AG, is familiar with the contents thereof, and agrees to recognise and abide by them in their entirety. The Terms and Conditions of Saffran AG are available in English and German. For interpretation purposes, only the German text shall be legally binding.

Place of jurisdiction

All agreements and contracts shall be subject to Swiss law. Place of performance and jurisdiction shall be Zurich. Saffran AG is also entitled to declare the place of residence of the client as place of jurisdiction.
